Meeting was called to order at 9:04 AM by Phil Humfrey at the Cal-Shasta Clubhouse.

**President’s Message:**

Phil welcomed the audience and had Mike Lemos of Tri-Counties, a new face in the audience, introduce himself.

**Minutes of Previous Meeting:**

A motion was made by Randy Tognazzini, 2<sup>nd</sup> by Charlie Hermes to accept the Minutes of the previous meeting as they appeared in the June Newsletter. The motion passed.

**Treasurer’s Report:**

Invoices to be paid: A bill from Whit’s Turn Tree Care for \$1,500.00 for emergency tree removal on Upper Cow Camp Loop was presented. A motion was made by Leo Kennedy, 2<sup>nd</sup> by Carl Steinkraus to pay the bill. The motion passed.

Sue Kennedy reported income of \$ 3,251.00, expenses of \$ 95,309.93, leaving an ending balance of \$ 46,725.59. A motion was made by Faron Goodwin, 2<sup>nd</sup> by Russ Johnson to accept the report as presented. The motion passed. **Correspondence:**

Sue Kennedy said a donation to SNRA in memory of Howard Van, who passed on in June, had been received from his family. Sue sent acknowledgements and thank you’s to the family.

**Committee Reports:**

**Electric Gate:**

Carl Steinkraus reported the gate has been working well. He and Jerry Ahrens have been working on the security cameras, including cameras donated by Randy Tognazzini. Carl had expenses for keys and camera power supply repairs and will have to be reimbursed.

**Membership:**

Sue Kennedy said she didn’t know of any new members but that there are still 9 members who have not yet paid their assessment for 2013, three of whom are more than a year behind. She noted that the Glaviano property had been sold and the \$1650 in back assessments was paid through escrow.

**Budget & Maintenance:**

Russ Johnson said we are waiting until after Sept. 1 (as per the Dept. of Fish and Wildlife) to continue the repairs to the Upper Crossing and clean out of the Lower Crossing. He plans to wait until after Labor Day to do pothole repairs.

**Fire Committee:**

Leo Kennedy reported people are having trouble downloading the Emergency Calling List off of the area website. Phil is working with Nick Koonce, the website keeper, to fix that. In the meantime, email Leo at [runningiron@wildblue.net](mailto:runningiron@wildblue.net) for a printable version of the Calling List. Also, if your name is on that list, please make sure your phone number is correct. If not, contact Leo. If you want to be put on the Emergency Calling List, contact Leo.

**Old Business:**

Change of website name/address. Phil continued the discussion of changing from "lakenacimientosouthshorearea.com" to something easier to remember and to type for the area website. No new name/address was suggested. Discussion to be continued.

**New Business:**

1. By-Laws Review - Phil had previously suggested modifying the By-Laws (Article VI - DUTIES OF OFFICERS, section 4) to change the term "audit" to "review". Since the By-Laws were originally written, the term "audit" has changed to mean a very specific, in-depth and costly examination of the accounts. What was intended in the By-Laws was a periodic inspection of our accounts by an independent professional accountant – a review. Board members had other suggestions for By-Law changes. Phil called a recess of the Board meeting at 9:50 for an informal discussion of the proposed changes. At 11:35 the Board meeting reconvened. Randy Tognazzini will prepare the changes that were discussed. He will also check with an attorney on a few points. A motion was made by Faron Goodwin, 2<sup>nd</sup> by Russ Johnson to approve up to \$1900 for attorney fees. The motion passed. The Board intends to have the changes published in time for a membership vote at the October 13<sup>th</sup> Members meeting.

## Back by Popular Demand!

### Community Emergency Response Training C.E.R.T.

CERT is returning to Heritage Ranch. This is your opportunity to receive the training that is growing in popularity. The North SLO County CERT program is offering classes at Heritage Ranch beginning July 11, 2013 at the Heritage Ranch Rec Barn.

What if you dialed 9-1-1 and there was a busy signal? What if there was no dial tone at all? CERT will train you how to navigate your way through a home emergency or a major incident. Don't be a victim! CERT will teach you when and how to shut off utilities, the proper way to use a fire extinguisher and put out a fire, how to identify a variety of injuries and how to treat them, and how to lift heavy debris off a trapped person. These are crucial skills to have and own. You can use these skills in your home or in the community assisting others. Keep your family safer through the knowledge that you learn in CERT classes.

Classes are taught by professional First Responders and trained personnel. Students receive a CERT training manual, 12 hours of instruction and three hours of hands on training. Prior to graduation, all students receive a CERT equipment backpack with basic responder equipment including: a first aid kit, a hard hat, goggles, gloves, a utility wrench, a crow bar, a lumber crayon, caution tape, and a flash light.

Cost of the classes, including all the items mentioned above, is \$50.00 per student. Snacks and refreshments are provided at each class and a lunch is provided upon graduation.

Come learn how to prepare your home, gain basic First Aid skills, extinguish small fires, and protect your family.

Classes are held Thursday evenings, July 11, 18, 25, and August 1 from 6 PM to 9PM. The final class is Saturday, August 3, 2013 from 9:00 AM to Noon.

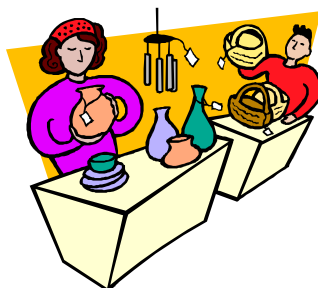
