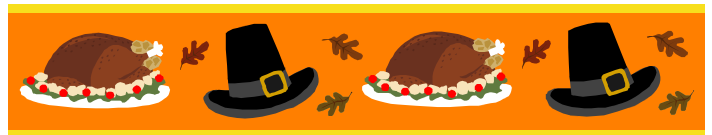

What to do if the keypad at the RDR electric gate locks up.

Back away from the keypad and off the safety loop in the road. Get out of your vehicle and press the # key on the keypad. You can then pull up to the keypad and enter your code. Be sure to press the # key before you enter your code. When entering your code press the keys slowly.

SNRA ROAD ACCESS

All SNRA members are reminded that the easement access for our roads is only twenty-five (25) feet wide in most areas. We **do not** have the right, or the permission to venture off the roads. You **may not** take your vehicles, ATV's, or motorcycles off road!! In the event someone is caught off road they will be reported to the SLO County Sheriff, and appropriate legal action may result.

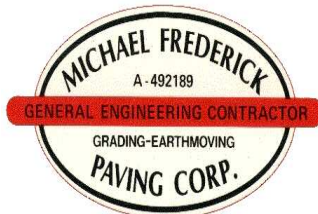

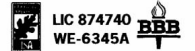
