Minutes of the Previous Meeting

There were no corrections or additions to the minutes of the last meeting, a motion was made by Randy seconded by Leo to approve the minutes as they were printed. Motion carried.

Treasurers Report

A motion was made by Jim and seconded by Randy to accept the treasurer's report as presented, motion carried. Beginning balance is \$58,814.76. Income of \$7,951.04 was received. Expenses of \$67.75 were paid leaving a balance on hand of \$66,833.55.

Correspondence

A letter sent to Mr. Hogan was reviewed by the board.

Electric Gate

Carl reported he and Jerry performed repairs on the main gate and it is now working fine. All locks were removed from the Running Deer gate, as they are no longer needed because the gate is electric. Keys will still work on the emergency exit gate.

Membership

Betty reported private property owner Mark Glaviano has been served to appear in small claims court for nonpayment of dues. A motion was made by Charlie, seconded by Ken to accept the exemption notice from Mr. Kopack for unimproved property. Motion carried. Dues are due by the end of this month.

Budget & Maintenance

Monterey County is requesting pictures of the trees needing to be cut on the SNRA right-of-way. Pictures will be provided to MCWRA for followup.

Fire Committee

Leo reported you can burn but must first have the required burn permit.

Old Business

Russ reported and the board agreed we need to increase our D & O insurance to two million dollars based on the recommendation of our carrier Guy Knapp. A motion was made by Leo, seconded by Jim to obtain a policy for two million dollars of coverage. The motion passed. Russ was asked to obtain a quote for D & O insurance and an umbrella policy.

Phil requested we encourage our members to enroll in the Quagga Mussel Resident Vessel Program. The next class will be on April 21, 2013. First, you must obtain and send in an application to the County by April 12, 2013 to attend the class. For more information, call Phil Humfrey at 238-9462.
