South Nacimiento Road Association, Inc. (SNRA) August 10, 2014 Board Meeting Minutes

Meeting was called to order at 9:02 AM by Phil Humfrey at the Cal-Shasta Clubhouse.

Roll Call:

Present: Phil Humfrey (Pres.), Ken Thomas (Vice Pres.), Chuck Enterline (Sec.), Sue Kennedy (Treas.), Representatives: John Hunter, Steve Selby, Ken Thomas from Cal-Shasta; Bill Barton (substitute), Russ Johnson (by phone) from Private Owners; Leo Kennedy, Jerry Ahrens (substitute) from Running Deer; Brent McClurg from South Shore; Randy Tognazzini, Faron Goodwin from Tri Counties.

Absent: Jim Shockey, Carl Steinkraus.

President's Message: Phil introduced Chuck Enterline from Running Deer Ranch who had volunteered to be Secretary. A motion was made by Leo Kennedy, 2nd by Randy Tognazzini to elect Chuck as SNRA Secretary. The motion carried unanimously. Chuck gave his email: clubchuck1@yahoo.com.

Minutes of Previous Meeting:

A correction to the May 18, 2014 Minutes was made: Russ Johnson was present, not absent.

A motion was made by Randy Tognazzini, 2nd by Leo Kennedy to accept the corrected Minutes of the previous meeting as they appeared in the May Newsletter. The motion carried.

Treasurer's Report:

Invoices presented for payment: Sue Kennedy presented an invoice from Michael Fredericks Paving for \$126,625.00 for the contracted road work. A motion was made, seconded and carried unanimously to pay the invoice.

Sue Kennedy reported for the months on May, June and July there was income of \$8,845.61, expenses of \$2,402.70, leaving an ending balance of \$152,710.21. A motion was made by Leo Kennedy, 2nd by Faron Goodwin to accept the report as presented. The motion passed. Sue reported on the successful T-shirt sales over the Memorial Day Weekend. With the generous donation of shirts and caps from Tim and Debbie Kopack and Yesterdays Sportswear, \$3,725 was raised at the front gate.

Renewal of the General Liability insurance policy was discussed. Phil and Russ Johnson (on the phone) brought up the approximately \$500 in last year's premium to cover the area of the front gate. It is a lot of premium for not too much coverage. Jerry Ahrens made a motion, 2nd by Leo Kennedy to drop that part of the policy. The motion carried unanimously. The policy is still out to bid through McGee Insurance.

Correspondence:

Sue Kennedy received and forwarded to all the Board members the Review of Books done by Jane Calder in Arroyo Grande. There was no charge for the review. Ms. Calder said she doesn't charge for Non-profit organizations.

Committee Reports:

Electric Gate: To get the new contractors code, contact Leo Kennedy at www.runningiron@wildblue.net to be put on the list for code change notification.

Jerry Ahrens reported on repairing one of the key pads.

Membership: Sue Kennedy reported on new members in Running Deer Ranch. Mike and Jolene Herrick bought the John's property on Running Deer Rd.

Budget & Maintenance: Phil Humfrey summarized the road work that had been done by M. Fredericks Paving. A very good job – the roads look good. But he and Russ are concerned that the work was done so late this year. There was some discussion of how to get Fredericks to do our work earlier in the year.

Assessment and Budget for the 2014-15 fiscal year: A Multi-Year Road Maintenance and Repair Plan was presented by Russ Johnson and a budget to pay for the 2014-15 work was proposed. A motion was made by Faron Goodwin, 2nd by Brent McClurg to keep the assessment for 2014-15 at \$375. The motion carried unanimously.

After the meeting Sue Kennedy discovered the figures in the proposed budget were incorrect. She corrected them. Russ Johnson adjusted the proposed road work for 2015 and they sent the corrected documents around to all Board members for an e-mail vote. Leo Kennedy made a motion, 2nd by Jim Shockey to accept the corrected Proposed Budget and Road Maintenance Plan. The motion carried via e-mail vote. The corrected Proposed Budget and the Multi-Year Road Maintenance & Repair Plan will be published in this Newsletter.

South Nacimiento Road Association Multi-Year Road Maintenance & Repair Plan

As of this writing, all of our road repair and maintenance work has been completed as planned. Our accomplishments include repairs to 85,600 square feet of surface on Running Deer Road, 50,000 square feet of surface on Gage Irving Road as well as 50 tons of hot patch maintenance work spread over several miles of our roads. Our systematic approach to road repairs and maintenance has been successful since 2009. As we go forward, it is the intent of the Board that we continue this method. To that end, in 2015 we plan on the following: YEAR 2015

General repairs and maintenance/patch and level @ \$36,635.00

Chip seal allowance @ \$60,000.00

Oiling and seal coating allowance @ \$25,000.00

Drain swale/edge of road repairs @ \$8,000.00

TOTAL REPAIRS & MAINTENANCE @ \$129,635.00

YEARS 2016-2018

For member information and planning purposes, SNRA will plan on the following yearly general allowance estimates for our on-going road repairs and maintenance. Please understand that we cannot predict failures and/or emergency repairs. In addition, volatile oil prices erode our buying power so year on year we get less for our money.

General repairs and maintenance/patch and level @ \$50,000.00

Chip seal allowance @ \$50,000.00

Oiling and seal coating allowance @ \$20,000.00

Drain swale/edge of road repairs @ \$5,000.00

TOTAL REPAIRS & MAINTENANCE @ \$125,000.00
