SNRA GENERAL MEMBERS MEETING

Oct. 8, 2017

Call to order:

The meeting was called to order by Pres. John Hunter at 9:03AM at the Cal-Shasta Clubhouse.

Audience included Josh Taylor, Cal Fire Battalion Chief, and 3 fire fighters from the Las Tablas station, and several SNRA members.

President's Message:

Welcome visitors. The ballots cast for the 2017-18 Proposed Budget are being counted now.

Minutes of Previous Meeting:

(8/13/2017) reviewed by e-mail, were presented for any changes.

MOTION: Ken Thomas made the motion to accept the Minutes, Leo Kennedy seconded it. Motion passed unanimously.

Treasures Report:

Sept. 24 a check for \$500 went to SWCA Environmental Consultants for a biological survey of the area around Sandy Creek as part of the Sandy Creek Sediment Removal project.

August: Beginning balance of \$44,865.34, income of \$2020.00 expenses of \$1,729.60. August 31 is the end of the fiscal year, so we finished the year with a balance of \$45,155.74. Sept. had income of \$00, expenses of \$675.22 for a closing balance of 44,480.52. There were no invoices to be paid.

MOTION: Faron Goodwin made a motion to accept the Treasurer's Report, John Runnels seconded it. Motion passed unanimously.

Annual Review of Insurance Coverage:

Budget and Maintenance:

Leo reported on work completed this year by M. Fredericks Paving. Much of the work was to clean out culverts and repair roads damaged by rains and masses of silt runoff from the 2016 fire. There are two projects to complete before this rainy season: Repair to the upper crossing and the Sandy Creek Sediment Removal project.

Russ reported on issues with Sandy Creek. A biologist's survey was submitted to the Dept. of Fish and Wildlife as part of the permit application process. A new request from DFW is to not work in the area during the Raptor nesting season (Feb. to Oct.)

MOTION: Bill Gough made a motion to continue with the permit process and plan to get work done outside of the raptor season, Carl Steinkraus seconded the motion. The motion passed unanimously.

Fire Committee:

Leo Kennedy will be putting together a new Fire Call list.

Representatives from each area are to contact Cindy McGee to update their fire call lists which can be posted on the SNRA Website

Josh Taylor from Cal Fire reported on recent fires in Tri Counties. They seemed to have been electrical in nature. He reported on work that is planned to be done in the area as part of the Fire Safe Council. The CA Conservation Corp. will begin clearing trees and brush as part of a \$30,000 grant. A \$40,000 grant may become available in December.

Chief Taylor advised to NOT call the Cal Fire Las Tablas Station directly to report a fire. ALWAYS call 911. A direct line, to assure you are not connected to Monterey County 911 (Which can happen based on our proximity) is: 805-543-4242 and for a direct line to SLO Sheriff, call 805-543-7082. **Both of these numbers are for emergencies ONLY!**

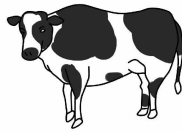

Instructions For Fire

In the event of fire inside Running Deer Gate, first call 911. Then call one person at the top of the list. If you can't reach either person, proceed to the lower levels, especially in the area closest to the fire, until you reach someone who will call the rest of the list. Or, you can do the calls. If you help to fight the fire please wear closed shoes and long pants. If you are hurt, firefighters must tend to you instead of the fire.

Station people at intersections to guide emergency crews; the fire crews who respond may not be local!
