Minutes of Previous Meeting: (Oct. 10, 2020) were presented for approval.

Motion: Randy Tognazzini made the motion to accept the Minutes. Leo Kennedy seconded. Motion passed unanimously.

Treasures Report: Oct. began with \$167,884.07. Income: \$420.00, expenses: \$145,315.07, balance: \$22,989.00.

Motion: Ken Thomas made a motion to approve the Treasurer's Report. John Crass seconded. Motion passed unanimously.

<u>Correspondence:</u> John Hunter received an e-mail a well as a letter from the Woodworths regarding their response to the Board's letter requesting they trim their trees along Running Deer Rd. After a long discussion, Ken McAlister volunteered to contact them and see what could be worked out.

Committee Reports:

--Electric Gate: Codes were given. Ken McAlister said he would take charge of the gate maintenance for now. He does not want to be called directly. Any problems with the gate should be reported to your SNRA rep.

- --Membership: New member in Cal-Shasta, Jessica Huston, has taken over the membership from her parents. Welcome, Jessica!
- --Budget and Maintenance: Leo indicated the contractor road work is completed for this year. He is putting Botts Dots on Running Deer Rd., just in from the main gate, to try to slow drivers down, coming and going. He needs to buy more adhesive pads.

Motion: Leo made a motion to approve up to \$100 for the pads. Ken Thomas seconded. Motion passed unanimously.

John Hunter reported on the ongoing talks with Monterey Co. about replacing a cattle guard. We won't be taking any actions at this time. MCWRA is talking with the lease holder.

Fire & Emergency Response Committee: Russ Johnson reported there was a small fire, near Icy Creek, which was started by a new Cal-Fire crew that was training in the area. It was put out quickly and less than 2 acers were burned. Regarding fuel reduction projects for the year ahead, Russ said the state has suspended all funding for now.

Lee Davis again presented our options for the Emergency Text Message System. After a discussion, it was decided to fund the \$49.00 a month plan. **Motion:** Leo Kennedy made a motion to approve \$49/month. Cindy McGee seconded. Motion passed unanimously.

Old Business:

Sue Kennedy suggested we make a plan for the weed spraying for next year. Ken Thomas said he would take the lead.

New Business:

Newsletter/Web Site. Cindy McGee said any changes or updates that clubs/areas want made to their tab on the website should go to her.

Three Minutes to Address the Board: None.

Announcements: Cal-Shasta is having the annual Holiday Craft Fair on Saturday, November 14 at the Clubhouse.

Next meeting will be Jan. 17, 2021 at the Cal-Shasta Club House 9:00 am.


