SNRA BOARD MEETING

Jan. 17, 2021

Call to order: The meeting was called to order by John Hunter at 9:00 AM.

Roll Call: John Hunter (Pres.), Ken Thomas (VP), Chuck Enterline (Sec.), Sue Kennedy (Treas.), Ken Thomas, Cindy McGee & Lee Davis (Cal-Shasta), Russ Johnson & Jeff Amos (Private Owners), Leo Kennedy & John Crass (Running Deer), Brent McClurg (South Shore) [No Tri Counties reps. present].

President's Message: *It's a NEW YEAR*

Minutes of Previous Meeting: (Nov. 10, 2020) were presented for any changes.

Motion: Ken Thomas made the motion to accept the Minutes, Cindy McGee seconded it and motion passed unanimously.

Treasures Report: Nov. began with \$22,989.00. Income: \$480.33 Expenses: \$289.42 Balance: \$23,179.91. Dec. Income: \$0.17 Expenses: \$294.19 Ending balance: \$22,885.89.

Motion: Jeff Amos made a motion to approve the report, John Crass seconded and motion passed unanimously.

Committee Reports:

Electric Gate: Codes were given out. Carl Steinkraus has moved away. Leo Kennedy is now in charge of gate locks and clickers. If you notice any problems with the gate, contact your SNRA rep. To be put on the list for email notification of the monthly guest/contractor code contact Leo at kennedyrjr@gmail.com.

Membership: None

Budget and Maintenance: The trees along the roadside at the front gate were discussed, again. The owners have done some trimming, but still not enough.

Motion: Russ Johnson made a motion to notify the owners they have until the first week of February to resolve the issue and then SNRA will do the trimming. It was seconded by Leo Kennedy. The motion passed unanimously.

Russ Johnson will write a letter to the owners to inform them of the plan.

A meeting was held with members of the SNRA Board - (John Hunter, Leo Kennedy & Russ Johnson), Tom Shepard from MCWRA and Darren Shetler (Cattle Lease Holder) on December 27th to discuss the location & installation of a new 20ft cattle guard north of Town Creek. They agreed on a location and arrangement for the installation. Monterey County is responsible for the cattle guard and installation and SNRA may be responsible for the road paving up to the guard once it is installed.

Plans for this year's road work have not yet been discussed.

Fire & Emergency Response Committee: Russ Johnson reported the governor has removed all new monies for fire fuel reduction. Grant money is also frozen for now. There has been extensive clearing of brush and trees on Mountain Ranch Rd. by Cal-Fire crews. Burn permits are now available. Go to slocleanair.org for information on Burn Days and to apply for a permit. There is a new sign on the front gate with this information.

Lee Davis reported that the Emergency Text Messaging program has been set up and tested by a few members. More information will be in the Newsletter.

Old Business: Weed spraying along the roads will be done by members of the Board. \$3,500 is the targeted cost. Cindy McGee recommended they keep close track of hours and costs for the Board to use in future budgeting.

New Business: None

Adjournment: Lee Davis made a motion to adjourn, John Crass seconded it. Motion passed unanimously.
