SNRA BOARD MEETING March 14, 2021

Call to order: The meeting was called to order by John Hunter at 9:00 AM at the Cal-Shasta Clubhouse.

<u>President's Message:</u> Thank you to all of the Board Members for their friendship and volunteer efforts. It is a pleasure working with everyone.

Minutes of Previous Meeting: (Jan. 17, 2021) were presented for any changes.

Motion: Randy Tognazzini made a motion to accept the Minutes, Lee Davis seconded it and the motion passed unanimously.

Treasures Report: January began with \$22,885.89, Income: \$7,800.00 Expenses: \$977.77 Balance: \$29,708.12. February, Income: \$12,835.00 Expenses: \$6,616.78 Ending balance: \$35,926.34.

Motion: Cindy McGee made a motion to approve the Treasurer's Report, Faron Goodwin seconded and the motion passed unanimously.

Invoices to be paid: 1) Lee Davis, \$147 for TextMark subscription. 2) Richard Coffee, \$1,350.00 for D & O insurance.

Motion: Faron Goodwin made a motion to pay these invoices, Leo Kennedy seconded and the motion passed unanimously.

Committee Reports:

Sue presented three Applications for Unimproved Property Fee Discount. All have been approved for the last several years.

Motion: Leo Kennedy made a motion to approve the requests, Jeff Amos seconded it and the motion passed unanimously.

Budget and Maintenance:

SNRA coordinated some tree trimming and brush clearing along the roadside just in from the front gate.

Leo has talked to Leonard of M. Fredricks Paving to begin planning road work projects for the year. Leonard said to wait a little longer for further rain before assessing repair needs. Leo talked about some areas likely to need attention.

The new cattle guard, to be installed up the hill from the lower crossing, is Monterey County's project. SNRA is assisting to make this a smooth & neighborly effort which could be combined with other road work when Frederick's is already working here.

Fire and Emergency Response Committee: Most of the clearing at the far end of Mountain Ranch Rd. has been completed by the National Guard crew from Camp San Luis. Cal-Fire may be in to do some burning of the piles of downed wood along the road. Cal-Fire has a survey crew in as part of a state-wide mapping of Severe Fire Danger areas. Russ said the state has allocated some money for fire prevention projects. Grant requests are in; may see some funding by August (?).

Thanks to Ken Thomas for installing the "one lane ahead" signs on Cal-Shasta Hill.

Roadside weed control: John Crass has acquired herbicide and weed spraying will begin soon.

Lee Davis reported on the Emergency Text Messaging system that we are putting in place. 105 members have enrolled in the service. Lee suggested each area rep should promote it to their members. There was discussion about keeping the phone tree as part of the notification system. Sue Kennedy will contact the people currently on the phone tree to determine who can receive notification by text and who will still need a phone call in the case of an emergency.

<u>Web Editor:</u> Nick Koonce is changing the website hosting service. Cindy McGee is working with him to get all the information transferred and running smoothly. Any communities that need to update their information on the website should contact Cindy.

Adjournment: Ken Thomas made a motion to adjourn, Faron Goodwin seconded and the Motion passed unanimously. The meeting was adjourned at 10:28am.

SB55

A CA Senate bill known as SB55 is working its way through committees and will likely become law. Our properties are in a State Responsibility Area (SRA) and the Very High Fire Danger area. This law will **PROHIBIT any new construction on all properties** in an SRA with Very High Fire Hazard severity. It may affect all types of structures and removes any authority from the County level to approve structures going forward. Please pay attention to SB55 as it relates to building any "permitted" structures on properties within the Running Deer Ranch gate and voice your opinion accordingly. Click here to read the current proposed bill <u>SB55</u>. Also, the Federal government is simultaneously proposing a similar law through the Forestry Department to stop all construction in similar zones in California.

6 Yard Weight Limit on Concrete Delivery Trucks

Due to the abundance of rain in a short period of time, the current weight limit restrictions have been lowered to 6 yards.

As usual, we will notify you when the return of the eight yard limit for the dry season goes into effect.
