Minutes of Previous Meeting: (10-09-2022) One correction: \$400,000 in fire prevention grants, not \$4 million.

Motion: A motion was made by Leo Kennedy to accept the Minutes of the previous meeting with the noted correction. Jeff Amos seconded. The Motion passed unanimously.

<u>*Treasures Report:*</u> Oct. began with \$200,052.93. Income: \$1,602.00, expenses: \$168,934.84, leaving a balance of \$32,720.09.

Motion: Russ Johnson made a motion to accept the Treasurer's Report; Leo Kennedy seconded. The motion passed unanimously.

-Electric Gate: Leo gave out the gate codes.

-Membership: No new members to report.

-Budget and Maintenance: Leo had nothing to report on the roads. Ken Thomas will do weed spraying when it is time.

-Fire/Emergency Response: Russ Johnson reported a controlled burn by Cal Fire is going on; the brush isn't burning easily so Cal Fire is still working on it.

Cal Fire Las Tablas station will remain open through Dec. 2022.

Through the Fire Safe Council grant, the fuel reduction on High Meadow, Maple Canyon and Tres Vistas project is still pending, but the funds are in place.

Russ said that there is still quite a lot of grant money for fuel reduction projects; Board members are encouraged to ask their clubs for suggestions, then contact Russ.

The community has been certified "Firewise" for the year. Thank you to those who turned in your 'fuel reduction' hours to your rep.

The Firewise Community Certification may help reduce your insurance costs – ask your agent.

Russ gave out Cal Fire brochures to be distributed to members; there are new regulations going into effect regarding required clearance around property, etc.

Thank you both, Lee and Eric, for stepping up.


Three Minutes for Members to Address the Board: None


