SNRA GENERAL MEMBERS MEETING

October 8, 2023

Call to order:

The meeting was called to order by Vice President Ken Thomas at 9:04 AM at the Cal-Shasta Clubhouse.

President's Message:

On behalf of the SNRA board, I'd like to thank and acknowledge the property owners who made their appearance at the recent court hearing in Paso Robles regarding NRWMAC. The pending litigation is important to us all and the future of water management at Nacimiento lake. All of us together demonstrated the importance of this case by your appearance. I hope to see you all again when we reconvene in November to help "save the dragon".

Minutes of Previous Meeting:

The Minutes of the August 13, 2023 meeting, as published in the Newsletter, were presented for approval. MO-TION: Faron Goodwin moved to approve the Minutes; Russ Johnson seconded. The motion passed unanimously.

Treasurer's Report:

Invoices were presented for payment: \$3,200 to Mid-Coast Geotechnical for soil studies. \$66.91 to Sue Kennedy for supplies given to Cal-Shasta as a thank you for the use of the clubhouse.

MOTION to pay made by Brent McClurg, 2nd by Roger Staben. The motion passed unanimously.

The Treasurer's Report was presented. Bank balance at the beginning of July was \$179,351.87, income of .17, expenses of \$297.29. August income of \$1,810.17, expenses of \$1,855.57. September (beginning of the new fiscal year) income of \$7,930.16, expenses of \$521.09. Closing balance for Sept. of \$186,418.25. Sue noted that the large balance is due to not yet being billed for much of the work that has been done by M. Fredericks Paving this year. Approximately \$85,000 of work has been completed.

MOTION: Leo Kennedy moved to accept the Treasurer's Report; Rober Staben seconded. The motion passed.

Report on Insurance Coverage:

The Directors and Officers Insurance coverage is through U.S. Liability Ins. Co. Richard Coffey is the agent. Coverage is \$2 million; each claim and in the aggregate. Annual premium \$1,550 paid April 12, 2023.

General Liability coverage is through Evanston Insurance Co. McGee Insurance, San Luis Obispo is the agent. Coverage is for \$1 million each occ; \$2 million in the agg. Annual premium is \$1,389.75 paid August 31, 2023.

Correspondence:

A very nice letter of thanks for all the work done by the Board and on the roads was received from Mary Bishop of Ranchos del Lago.

Committee Reports:

Electric Gate -

Leo Kennedy gave out the gate codes. Due to AT&T service being out for a time, the code could not be changed. The code is the same as it was in September. No other gate or camera problems were reported.

Budget & Maintenance –

Leo Kennedy reported progress on the "feasibility study" for the Running Deer Rd. washout repair. The soils report and topo map have been completed. The next step is to engage a civil engineer who can put together a plan for the repair and an estimate of costs. Once we have an idea of how to repair it and a figure for the cost, as well as an alternate bid for upgrading Gage Irving to be our permanent road, we can present these to the membership to decide whether to repair Running Deer Rd. or put more money and work on the Gage Irving bypass.

Fredericks will be back this week to complete the already approved and budgeted work for this year: more work on Gage Irving bypass – earth moving and paving. There will be more work done on Cal-Shasta Hill and at Icy Creek – further cleanup from the winter storms. Also, general road patching, culvert cleaning and repair, edge grading, etc. will be done.

Fire & Emergency Response Committee –

Russ Johnson said the wood chipping crew, provided by Fire Safe grants, will be in Tuesday through Friday to chip the limbs and brush that has been cleared and set on the roadside.

Old Business: None.

New Business:

Results of the Budget vote: YES -113, NO -4.

Shirley Robinson voiced concern that Gage Irving Rd., through Running Deer, (the current bypass and the emergency exit) isn't maintained as well as Running Deer Rd. She asked the Board to please plan to improve the quality of the road.
